Your donation of \$500 through payroll deduction amounts to less than \$1 a day (after tax reduction). Your donation is divided equally across the number of pay periods you have in a one-year period, typically 26 pay periods, making it easy for you to make a significant donation. A \$500 donation spread across 26 pay periods amounts to \$19.23 per pay (before tax reduction).
